## 4. First-aid measures

## 5. Fire-fighting measures

## 7. Handling and storage

### Precautions for safe handling

To maintain product quality, do not store in heat or direct sunlight. Keep containers closed when not in use. Store in a well-ventilated place. Room temperature - normal conditions. Do not allow material to freeze. Keep away from food, drink and animal feedingstuffs. Use care in handling/storage. Store away from incompatible materials (see Section 10 of the SDS). If frozen, product may separate. Thaw completely at room temperature and stir thoroughly prior to use. Keep this material away from food, drink and animal feed.
