##### Prevention

### 4. First-aid measures

**Methods and materials for containment and cleaning up**

Extinguish all flames in the vicinity. Local authorities should be advised if significant spillages cannot be contained. The product is immiscible with water and will spread on the water surface.

Large Spills: Stop the flow of material, if this is without risk. Absorb in vermiculite, dry sand or earth and place into containers. Prevent entry into waterways, sewer, basements or confined areas. **Precautions for safe handling**
