4. First-aid measures

Inhalation	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or doctor/physician if you feel unwell.

5. Fire-fighting measures

6. Accidental release measures

Methods and materials for containment and cleaning up

Extinguish all flames in the vicinity. Local authorities should be advised if significant spillages cannot be contained. The product is immiscible with water and will spread on the water surface.

Large Spills: Stop the flow of material, if this is without risk. Absorb in vermiculite, dry sand or earth and place into containers. Prevent product from entering drains. 7. Handling and storage

Precautions for safe handling

Appropriate engineering controls
