#### 4. First-aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. Under normal conditions of intended use, this material is not expected to be an inhalation hazard.

#### 5. Fire-fighting measures

<b>Methods and materials for containment and cleaning up</b>	Extinguish all flames in the vicinity. Local authorities should be advised if significant spillages cannot be contained. The product is immiscible with water and will spread on the water surface.  Large Spills: Stop the flow of material, if this is without risk. Absorb in vermiculite, dry sand or earth and place into containers. Prevent product from entering drains. Prevent entry into waterways, sewer, basements or confined areas. Clean up in accordance with all applicable regulations. Following product recovery, flush area with water.  Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). ## 7. Handling and storage

**Precautions for safe handling** Do not cut, weld, solder, drill, grind, or expose containers to heat, flame, sparks, or other sources of ignition. Do not breathe dust/fume/gas/mist/vapors/spray. Avoid contact with skin and eyes. Do not ingest. Avoid prolonged and repeated contact. Do not get this material on clothing. When using, do not eat, drink or smoke. Use only in well-ventilated areas. Wash thoroughly after handling. Do not empty into drains. Handle and open container with care. Wash contaminated clothing before reuse. Observe good industrial hygiene practices.

**Conditions for safe storage, including any incompatibilities** To maintain product quality, do not store in heat or direct sunlight. Keep containers closed when not in use. Store in a well-ventilated place. Room temperature - normal conditions. Do not allow material to freeze. Keep away from food, drink and animal feedingstuffs. Use care in handling/storage. Store away from incompatible materials (see Section 10 of the SDS). If frozen, product may separate. Thaw completely at room temperature and stir thoroughly prior to use. Keep this material away from food, drink and animal feed.
